Sub: - Guidelines to install solar net meter by AMISP under PMSG: MBY.

The Government of India has approved the PM Surya Ghar: Muft Bijli Yojana on 29th February, 2024 to increase the share of solar rooftop capacity and empower residential households to generate their own electricity. The target of installing 1crore RTS installations on households throughout the country by the end of FY-26-27 set under this scheme.

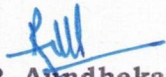
MSEDCL itself set target of 20 lakhs of RTS installation in Maharashtra & to achieve it, various initiatives under taken by MSEDCL. In the process, RTS Vendor Portal deployed since 22nd Oct 24 to implement "Faceless & Paperless" initiative. In detail guidelines issued by this office vide letter under reference- 2. Also, solar net meter has been provided and install by MSEDCL through AMISP for RTS installations under PMSG: MBY as per letter under reference- 3. The timeline to install net meter already defined in the letter as under reference- 2.

In spite of all out efforts as above, the daily RTS installation progress is not upto the mark. The count of release order generated through RTS Vendor portal but meter not assigned increasing rapidly. The competent authority reviewed the progress during the meeting through VC on 07th Dec 24 with AMISP & Vendors, where it is observed that field officers are not allowing AMISP to install solar net meter in case generation meter not made available/ installed by Vendor/Consumer.

Hence it is instructed to all field officers to ensure that after release order through RTS Vendor portal, AMISP will replace old meter by solar net meter within timeline specified in the letter as under reference- 2 without waiting for generation meter installation. Also concern field officer shall ensure installation of generation meter immediately after release order and shall feed generation meter details on NC portal.

Pl note, the deviation from guidelines as above by the field officer if any will be viewed seriously.

The instructions issued to be circulated upto field officers immediately.
